B. Adoption of Millage Rates for Tax Year 2019

BE IT RESOLVED, that the following millages are hereby levied on the 2019 tax roll on all property subject to taxation by Plaquemines Paris Hospital Service District No. 1:

MILLAGE

Hospital District Tax---15 Years (1055 009): 2.750 mills Hospital Service District No. 1---10 Years (1055 0022): 3.130 mills

BE IT FURTHER RESOLVED, that the proper administrative officials of the Parish of Plaquemines, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2019, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.
