## A. Adoption of PMC's Policy Legislative Mandates- Federal Funds

Ms. Jennifer Harris gave a brief overview and mentioned that PPC is currently under a Federal Legislative Mandates review. They require PMC/PPC to have a policy in place which covers the legislative mandates for federal funds. Sandra Lode developed this policy. There were no questions.

## Item IX. Old Business: (Adams)

## A. Primary Care update

Ms. Harris said over the last few weeks, PPC has been continuing to screen and test residents for COVID-19. There has been an increase in patients in PPC. PPC has been advertising testing dates and locations in various ways, such as The Plaquemines Gazette newspaper, local news channels, social media, etc. At the PPC Board meeting, Ms. Harris asked for suggestions of other ways to advertise services offered through PPC. Louisiana's goal is to test 4% of the population for COVID-19. Dr. Kanter, with the Louisiana Department of Health, contacted PMC/PPC asking for support in partnering with the Louisiana National Guards to provide free mobile testing in various locations throughout the parish. As of today, one hundred fifty-two (152) tests have been performed. The staff has additional dates and locations each week and will advertise as such.

Ms. Harris gave a brief update on the 340B program. The 340B program is a program that helps uninsured patients get their prescriptions at a discounted rate. Delta Drugs and Russo's pharmacy will participate in this program. She hopes to start training staff in the upcoming weeks. Once training is complete, the program will be implemented. Mr. Adams asked Ms. Harris to provide a list of approved discounted medications.

Ms. Harris gave an update on the physician interested in PPC. PMC/PPC presented her with a contract and are awaiting a response. Ms. Prest will follow-up with Dr. Gaddis next week. Mr. Adams addressed the Board regarding the Co-Applicant agreement between PMC & PPC. He asked Ms. Harris to provide a copy of the co-app agreement to the Board for their review.

At last month's meeting, Ms. Prest updated the Board on the upcoming election for the Millage Adoption. Due to COVID-19, the election date was postponed to August 15, 2020. The required publishing prior to the election was stopped; therefore, we will have to start over with the four (4) consecutive postings. The first post will begin the week of June 8, 2020. Mr. Adams presented marketing ideas from Print-All. The Board discussed changes needed prior to final printing. There were no questions.

Mr. Adams informed the Board that the September 2020 PMC meeting will be held on the fourth (4<sup>th</sup>) Thursday instead of the third (3<sup>rd</sup>) due to a misprint in the newspaper.
