During the Zoom call, Dr. Naeem, the new Assistant Medical Director, spoke about his work with Ms. Monica Martin and Ms. Leslie Prest. He discussed our weekly staff committee meetings. He said everything has been working smoothly within the clinic, and everyone has been working hard as a team to provide the best quality of care.

Ms. Martin updated the Board regarding COVID testing for the month. As of March 18, 2021, we've tested five hundred and eighty (580) patients, and of that, sixty-one (61) tested positive. We've done sixty (60) Influenza tests, and eight (8) tested positive. As of March 18, 2021, we have administered eighteen hundred (1800) vaccines. She mentioned that PMC & PPC would be continuing to distribute vaccines throughout the parish. Ms. Prest talked about various companies within the parish that PMC has assisted with vaccine administration. Ms. Martin also spoke about our upcoming events. On April 1, 2021, together with PPC and the National Minority Health, PMC will host Hopping over COVID Easter basket drive-thru giveaway from 4 PM – 6 PM.

A. Primary Care Update

Ms. Harris gave a brief update regarding PPC. She said PPC administered vaccines to teachers and support staff, YMCA staff, and daycare staff interested in receiving the vaccine throughout the parish. As of March 18, 2021, PPC has distributed three hundred and thirty-five (335) to the PPSB school employees. Since February 25, 2021, PPC has administered 599 1st doses, of that two hundred and twenty (222) were distributed at the mass vaccine clinic held at the Buras Auditorium on March 15, 2021. Ms. Harris talked about a vaccine drive to be held on the Eastbank the first week in April. Ms. Harris noted everything is working smoothly in primary care, and PPC has seen a total of five hundred eighty-nine (589) patients in February.

Item X. COVID-19 Update

For March, Ms. Prest briefly mentioned that PMC vaccinated nine hundred and seventy-six (976) and tested five hundred and eighty (580) patients. She also said that the staff had been busy coordinating vaccine appointments and distributing vaccines throughout the parish. She said the ultra temp freezer that PPC ordered should be delivered next week, and PMC will have the capability to store the Pfizer vaccine. There were no questions.
